

MAPLE GROVE POLICE NEWS

Theft From Auto	11/13/15	6500 block of Balsam Lane – report of laptop stolen out of unlocked vehicle in driveway; no suspects at this time.
Theft From Auto	11/13/15	11600 block of 96 th Lane – report of wallet stolen from vehicle parked at business; credit cards were already used at another business, no suspects at this time.
Medical	11/13/15	9500 block of Ranchview Lane – report of person falling in driveway and getting head injury; on arrival direct pressure was applied to wound and person later transported to hospital by ambulance.

		plates found in dumpster while looking for tools taken. Several items missing and case currently being investigated.
Animal Complaint	11/17/15	10000 block of Pilgrim Way – report of dog at large in area; on arrival it was found same dog owner given verbal warning and this time was cited for incident.
Medical	11/17/15	7200 block of Timber Lane – report of person unresponsive; on arrival person found in bathroom unresponsive. Officers assisted in getting person into ambulance who was then transported to hospital.
Theft	11/18/15	12000 block of Elm Creek Boulevard – report of three suspects stealing items from business without paying; on arrival officers located all three and arrested them for theft and drug possession.
Theft of Mail	11/19/15	8200 block of Niagara Lane – report of mail being taken out of mailbox; officers learned that fake checks were made and cashed on account. No suspects at this time.
Medical	11/19/15	12000 block of Weaver Lake Road – report of person falling and hitting head in parking lot of business; on arrival officers assisted with care of person until paramedics cleared officers.
