

MAPLE GROVE POLICE NEWS

Following is a synopsis of some of the incidents that occurred in the City during the week of November 20th, 2015 through November 26th, 2015. Please refer to City Web-Site Crime Mapping Section for additional details for the crimes of Burglary, Robbery, Arson, Theft and Vehicle Theft.

TYPE OF INCIDENT	DATE	DESCRIPTION
Suspicious Activity	11/20/15	12000 block of Elm Creek Boulevard – report of vehicle running for 2 hours in front of business with someone sleeping in it; on arrival person awoken by police and eventually arrested for DWI.
Slumper	11/21/15	12000 block of Elm Creek Boulevard – report of person sleeping in vehicle with temperatures in the teens; on arrival person was told to find a ride but wouldn't and got belligerent with officers, who then arrested them for obstructing the legal process.
Theft	11/21/15	6400 block of Merrimac Lane – report of satellite stolen of pole in yard of residence; no suspects at this time.
Medical	11/21/15	9100 block of Comstock Lane – report of person unconscious but breathing fine; on arrival blood pressure was checked and was low and person had weak pulse. Person transported to hospital by ambulance.
Drowning	11/21/15	11000 block of Fountains Way – report of person floating in pool at business, not breathing and unconscious; on arrival staff had done CPR bringing person back to breathing and conscious. Person transported to hospital by ambulance.
Traffic Complaint	11/22/15	Boone Avenue & I-694 – report of person driving all over the road; officer's located vehicle but vehicle fled officers. Vehicle eventually stopped and arrested for fleeing and DWI.
Safety Check	11/22/15	68 th Avenue & Lawndale Lane – report of juveniles playing on very thin ice; on arrival officers advised juveniles of the danger. Parents had also told them not to play on the ice earlier in the day.
Mail Theft	11/23/15	9400 block of Kirkwood Way – report of mail being stolen from mailbox; officers found that credit card mailed to residence had been used

		but was declined. No suspects at this time and Postmaster informed.
Theft	11/23/15	7600 block of Zanzibar Lane – report of bike stolen out of garage of residence; no suspects at this time.
Lift Assist	11/24/15	15000 block of 70 th Avenue – report of person falling out of bed and not being able to get up; on arrival officers found person on floor in bedroom and help them back into bed. They were not injured and needed no other help.
Shooting	11/24/15	94 th Avenue & Revere Lane – report of person being shot with a BB gun; officers noticed a small BB mark on right hip. Photos taken and BB placed into evidence. No suspects at this time.
Damage to Property	11/24/15	9300 block of Inland Lane – report of someone throwing squash at vehicle and breaking tail light; information taken and no suspects at this time.
Theft From Auto	11/24/15	12000 block of 82 nd Avenue – report of someone breaking out window of vehicle and stealing items from inside; officers interviewed witnesses who interrupted theft. Plate given of suspect vehicle and case being investigated.
Grass Fire	11/25/15	93 rd Avenue & Upland Lane – officers observed smoke in the area. Checked nearby park and found the males with a small fire near retaining wall. All three fled when they saw officers. Fire put out and a backpack, jacket and hats collected and placed into evidence. Suspects not located.
Damage to Property	11/26/15	8000 block of Shadyview Lane – report of someone putting paint all over garage door at residence; on arrival paint was being cleaned up. No suspects at this time.
Medical	11/26/15	6700 block of Yellowstone Lane – report of person feeling weak, sweating and having chest pain; on arrival officers learned of history of strokes and high blood pressure. Person transported to hospital by ambulance.

During this time period there were 28 property damage traffic accidents and one property damage injury traffic accident.
