| Trespassing | 7/10/15 | 17000 block of 69 th Place – report of juveniles trespassing in association pool area; on officer arrival persons located and cited for underage drinking. |
| Animal Complaint | 7/11/15 | 13000 block of 82 nd Avenue – report of two dogs locked in vehicle at business; on arrival temperature inside vehicle was 90 degrees and dogs were panting. Owner located and warned of ordinance. |
| Juvenile Problem | 7/11/15 | Area of Elm Creek Blvd and Grove Drive – report of several juveniles fighting; on arrival officers learned there was not fight, but several citations issued for underage drinking. |

| Damage To Property | 7/12/15 | 12000 block of 82 nd Place – report of two windows broken and siding damaged to residence by a pellet gun; on arrival officers investigated and found person who had shot the pellet gun. Both parties will work together to get damages fix, no charges at this time. |

| Prowler | 7/13/15 | 8300 block of Rice Lake Road – report of car prowlers in area; officers located several persons who had fled on foot and were arrested for theft, motor vehicle tampering and fleeing an officer. |
| Suspicious Activity | 7/13/15 | 13000 block of Grove Drive – report of kids under a tarp in back of pickup truck; officers located vehicle at business and found driver transporting children in bed of truck. Warned of dangers and all were seat belted in before leaving area. Child Protection Notified. |
