

MAPLE GROVE POLICE NEWS

Following is a synopsis of some of the incidents that occurred in the City during the week of October 16th, 2015 through October 22nd, 2015. Please refer to City Web-Site Crime Mapping Section for additional details for the crimes of Burglary, Robbery, Arson, Theft and Vehicle Theft.

TYPE OF INCIDENT	DATE	DESCRIPTION
Car Fire	10/16/15	I-94 and Mile Marker 213 – officer following vehicle noticed heavy smoke and small flames from undercarriage; officer pulled over vehicle and made driver aware. Fire department arrived and put fire in engine out.
Medical	10/16/15	6400 block of Ranchview Lane – report of male who fell after getting out of bed and was diabetic; on arrival person having small seizures. Paramedics started glucose with IV until person regained consciousness.
Theft From Auto	10/17/15	8400 block of Comstock Lane – report of two vehicles that had items stolen from inside overnight; no suspects or evidence to follow up on.
Fight	10/18/15	9300 block of Deerwood Lane – report of several people fighting outside a business; on arrival one group left when sirens were heard and the other did not want to press charges, no injuries.
Damage To Property	10/18/15	15000 block of Elm Road – report of several mailboxes hit by vehicle speeding through neighborhood; no suspects at this time.
Allergic Reaction	10/19/15	12000 block of Weaver Lake Road – report of person having reaction to new medications; on arrival person very shaky. Officers were cleared by paramedics, unknown if transported.
Theft From Auto	10/19/15	16000 block of 70 th Avenue – report of items taken from vehicle in driveway overnight; on arrival no evidence or suspects known.
Damage To Property	10/19/15	12000 block of Main Street – report of vehicle parked at Transit Hub having window smashed out; no evidence or suspects at this time.
Theft	10/2015	12000 block of Elm Creek Boulevard – report of person stealing items without paying for them; on arrival person arrested for shoplifting.

Medical	10/20/15	9800 block of Fernbrook Lane – report of person crashing bike and having a head injury; on arrival victim’s head was stabilized and then transported to hospital.
Graffiti	10/20/15	11000 block of 100 th Place North – report of graffiti written on power box, stop sign and light pole at intersection. Public Works notified to take care of graffiti.
Allergic Reaction	10/21/15	18000 block of 98 th Place – report of person being bitten by a bee and having a reaction; on arrival with North Memorial assisted in transport to hospital.
Theft From Auto	10/21/15	101 st Avenue and I-94 – report of person seen stealing items out of construction truck; on arrival officers arrested five parties involved in theft and other charges to follow.
Theft	10/21/15	9100 block of Annapolis Lane – report of utility trailer being stolen from backyard overnight; no suspects or evidence at this time.
Medical	10/21/15	8400 block of Jefferson Highway – report of person unconscious at business; on arrival person had no pulse so CPR was started. North Memorial arrived and officers regained pulse on person who was then transported to hospital.
Theft From Auto	10/22/15	6400 block of Monticello Lane – report of vehicle broken into parked in driveway and items stolen from inside; appears object used to pry open door causing damage. No suspects or evidence at this time.

During this time period there were 32 property damage traffic accidents and four property damage injury traffic accidents.
