

MAPLE GROVE POLICE NEWS

Burglary	12/11/15	7800 block of Ranchview Lane – report of an interrupted burglary where suspects ran off; officers set up perimeter and K9 track with no success in finding suspect. Crime lab called and case still active.
Animal Complaint	12/11/15	7600 block of Orchid Lane – report of a potbelly pig running loose in area; on arrival pig had been wrangled up by reporting party. Officer's took custody of pig and transported it to PUP's (Piggy Jail)
Theft From Auto	12/11/15	14000 block of Weaver Lake Road – report of two backpacks taken from unlocked vehicle in parking lot; no suspects at this time.
Theft	12/12/15	13000 block of Grove Drive – report of person taking items from store and not paying for them before leaving; suspect located and arrested for shoplifting.

Medical	12/16/15	6200 Nathan Lane – report of person falling out of bed and unable to get back up; officers arrived and found person on floor in bedroom unhurt and assisted in getting him back in bed.
Suspicious Activity	12/16/15	12000 block of 82 nd Avenue – report of person in parking lot trying doors on vehicles parked; on arrival no suspects located in area and no reported thefts or damage to vehicles.
Medical	12/16/15	9500 block of Polaris Lane – report of unconscious person on floor who was diabetic; on arrival person breathing but not responsive. Transported to hospital by ambulance.
Medical	12/17/15	9300 block of Kingsview Lane – report of person in and out of consciousness after falling; on arrival assisted with getting person to ambulance for transport.
Medical	12/17/15	6300 block of Ranchview Lane – report of child having difficulty breathing; on arrival officers provided oxygen until ambulance arrived for transport.
Amputation	12/17/15	13700 block of Grove Drive – report of person slamming finger in car door; on arrival finger bleeding and did not appear amputated. Officer applied sterile gauze. Husband notified to get kids while victim went by ambulance to hospital.

During this time period there were 31 property damage traffic accidents and three property damage injury traffic accidents.
