The City of Maple Grove will not issue permits to any person not authorized by this application and further, may request information necessary to verify authorization for any permit request. The City of Maple Grove, applicants and authorized employees agree to confidentiality of the information provided on this application form to prevent unauthorized persons from using such information to obtain a permit. It is the responsibility of the corporation, company, or individual to immediately notify the City of Maple Grove at 763-494-6370 of all changes in the information provided in this application. Permits may be requested until 3:30pm and will be processed in the order received. Processed permits will not be revised, altered, cancelled, or voided.

*Please call 763-494-6370 Mon – Fri , 7:30am - 3:30pm to request a daily overweight permit. Cost is a flat \$10.00 daily fee plus a \$2.00 per load charge. Allowed weight and/or time variances will be established by the Maple Grove Streets Dept and may fluctuate with weather and road conditions.
