Section 570 - Sign Fees

Section 570:00. Sign Fees. Permit fees for signs are hereby established in the amounts set forth in the subdivisions which follow.

Subd. 1. The Permit Fee as required by Section 345:15, Subd. 15 shall be determined by the cost of the sign, using the following schedule:

<u>Valuation of Sign</u>	<u>Fee</u>
\$1.00 to \$500.00	\$20.00
\$501.00 to \$1,000.00	\$20.00 for the first \$500, plus \$5 for each additional \$100 or fraction thereof, to and including \$1,000.
\$1,001.00 to \$2,000.00	\$45.00 for the first \$1,000, plus \$10 for each additional \$500 or fraction thereof, to and including \$2,000.
\$2,001.00 and higher	\$65.00 for the first \$2,000, plus \$5 for each additional \$1,000 or fraction thereof.

Subd. 2. All permit applications must be accompanied by proof of contract of purchase price.

Subd. 3. If a person begins work on any sign for which a permit is required, without having secured the necessary permits therefor, either previous to or on the date of commencement of such work, he shall, when subsequently securing said permit, pay double the fee provided for such permit, or shall be subject to the penalty provisions of this Code.

Subd. 4. There shall be no charge for a Special Permit in areas of special control (see Section 345:65, Subd. 5).

Subd. 5. The fee for a permit for the temporary use of banners, pennants and similar devices regulated pursuant to Section 345:15, Subd. 7, shall be in the amount of \$5.00. (Amended, Ord. Nos. 83-07, Sec. 4; 83-26, Sec. 9; 85-06, Sec. 5)

Section 570:05. Sign Hanger's License. The fee for a sign hanger's license required pursuant to Section 465:05 shall be in the amount of \$25.00. (Added, Ord. No. 83-26, Sec. 10)
