

MAPLE GROVE POLICE NEWS

Following is a synopsis of some of the incidents that occurred in the City during the week of October 2nd, 2015 through October 8th, 2015. Please refer to City Web-Site Crime Mapping Section for additional details for the crimes of Burglary, Robbery, Arson, Theft and Vehicle Theft.

TYPE OF INCIDENT	DATE	DESCRIPTION
Medical	10/2/15	9000 block of Nathan Lane – report of person falling in bathroom and breaking arm; on arrival assisted victim to ambulance who was then transported to hospital.
Theft From Auto	10/2/15	14100 block of 62 nd Place – report of someone entering open garage and taking items from unlocked vehicle; no suspects at this time.
Medical	10/3/15	7100 block of Annapolis Lane – report of person having seizures; on arrival person had another seizure while on scene. Person transported to hospital by ambulance.
Stolen Vehicle	10/3/15	9600 block of 63 rd Avenue – report of person going into yoga class and someone taking car keys from sweatshirt and taking vehicle; with a tracking device vehicle located in Minneapolis unoccupied. Case being investigated.
Theft	10/3/15	13700 block of Grove Drive – report of person stealing items from business and not paying for them; officers arrived and arrested person for theft.
Medical	10/3/15	7200 block of Teakwood Lane – report of person having major chest pain; on arrival officers assisted paramedics in carrying person down the stairs to the ambulance for transport.
Damage To Property	10/4/15	6200 block of Quinwood Lane – report of someone slashing all four tires on vehicle parked in driveway; possible suspect, but no charges at this time.
Unwanted Person	10/4/15	9600 block of Grove Circle – report of person refusing to leave business when asked; on arrival officers found that person to have a warrant and arrested them.
Medical	10/5/15	8200 block of Main Street – report of person who had fallen resulting in massive blood loss; on arrival pools of blood on floor, carpet

		and entry way. Person had fallen and cut open back of head. Officers assisted in applying sterile pads. Taken to hospital by ambulance.
Theft From Auto	10/6/15	7200 block of Jewel Lane – report of someone entering unlock vehicle in driveway and taking \$600 cash from inside; no suspects or evidence to be collected.
Damage To Property	10/6/15	12000 block of 92 nd Avenue – report of damage by neighboring kids to swing set in backyard; parents of kids would work with homeowner for repairs.
Burglary	10/7/15	6200 block of Meadowlark Lane – report of homeowner chasing two males that were in his garage; K9 track done and suspects located hiding in yard and arrested for burglary.
Theft	10/8/15	8000 block of Kirkwood Lane – report of packages delivered and left on steps were stolen; no suspects at this time.
Damage to Property	10/8/15	11500 block of 73 rd Avenue – report of passenger window broken out on vehicle parked at business; no suspects and nothing stolen from inside vehicle.
Medical	10/8/15	12100 block of 62 nd Avenue – report of person falling through sheetrock from garage attic; on arrival person was conscious and breathing but complained about pain in her head and others places. Transported to hospital.
Suspicious Activity	10/8/15	Dunkirk Lane & Weaver Lake Road – while officer was conducting routine patrol he noticed a vehicle driving on the wrong side of the road; upon contact driver was arrested for DWI.
