

MAPLE GROVE POLICE NEWS

Following is a synopsis of some of the incidents that occurred in the City during the week of July 24th, 2015 through July 30th, 2015. Please refer to City Web-Site Crime Mapping Section for additional details for the crimes of Burglary, Robbery, Arson, Theft and Vehicle Theft.

TYPE OF INCIDENT	DATE	DESCRIPTION
Weapons Complaint	7/24/15	Area of Elm Creek & Hemlock Lane – officer made a traffic stop on a vehicle for a signal violation and found driver to be under the influence of alcohol and carrying a gun; he was arrested for carrying the gun while under the influence.
House Fire	7/24/15	11000 block of 87 th Place – report of house struck by lightning and now power box on fire and burning siding; officer arrived and extinguished fire and turned off gas meter. Damage to siding and no injuries.
Vandalism	7/24/15	16000 block of 91 st Avenue – report of several vehicles in underground garage sprayed with a substance that washed off; officers located juvenile suspect who was trespassed from the property.
Animal Welfare	7/24/15	9400 block of Dunkirk Lane – report of puppy left in vehicle at business; on arrival officer took temperature inside vehicle of 91 degrees. Owner did not return after 15 minutes so officer took puppy out, but then owner returned. Verbal warning of state statute.
Traffic Complaint	7/25/15	Area of Hemlock Lane & I-94 – report of vehicle all over the road and jumping several curbs; officer made contact with driver who was then arrested for DWI.
Burglary	7/25/15	7900 block of Chesshire Lane – report of suspect entering unlocked residence while they were out on the lake and stealing several items from inside; on arrival officers could not locate any evidence. Case open and being investigated.
Suspicious Activity	7/25/15	12000 block of 87 th Avenue – report of homeowner hearing someone trying to get into residence and dogs began barking; on arrival officers could not locate anyone in the area and found nothing suspicious.
Traffic Complaint	7/25/15	11000 block of Fountains Drive – report of

		person sitting in turn lane and slumped over; officers made contact with driver who was later arrested for DWI.
Theft	7/26/15	8100 block of Archer Lane – report of several potted plants taken off front porch of residence overnight; no suspect information or possible evidence located.
Theft	7/26/15	12000 block of Weaver Lake Road – report of iPhone stolen from bench at hockey arena; officers later identified suspect from video, found them in parking lot and was arrested for the theft. Property returned to owner.
Medical	7/27/15	12000 block of 86 th Avenue – report of person falling and cutting chin open; on arrival officers learned victim was on blood thinners, but bleeding had been stopped. Victim transported by ambulance to hospital.
Damage To Property	7/27/15	9000 block of Sawgrass Glen – report of a bank of 40 mailboxes damaged in area; on arrival suspect had rocked bank of boxes back and forth until base was damaged. No suspects at this time.
Medical	7/28/15	6500 block of Lancaster Lane – report of young adult having chest pains and difficulty breathing; officers arrived at same time as paramedics and assisted in getting victim to ambulance for transport.
Theft	7/29/15	11000 block of Fountains Drive – report of suspect concealing items in purse and was confronted by loss prevention. While being escorted to office suspect fled out doors and left in vehicle; case being followed up on with vehicle information.

During this time frame there were 30 property damage traffic accidents and 1 property damage injury traffic accidents.
