

## MAPLE GROVE POLICE NEWS

Following is a synopsis of some of the incidents that occurred in the City during the week of February 12<sup>th</sup>, 2016 through February 18<sup>th</sup>, 2016. TYPE OF INCIDENT	DATE	DESCRIPTION
Animal Complaint	2/12/16	9600 block of Harbor Lane – report of wolf in backyard of residence; on arrival officer viewed video and saw that it was a coyote. No problems.
Medical	2/12/16	9300 block of Upland Lane – report of person falling on ice; on arrival officers assisted person in getting up, refused medical assistance.
Burglary	2/12/16	14900 block of 63 <sup>rd</sup> Place – report of someone stealing items from vehicle parked in garage, garage door was left open overnight; no suspects or evidence.
Theft	2/13/16	12400 block of Elm Creek Boulevard – report of two suspects stealing merchandise from store without paying; on arrival officers arrested both parties for theft. All property returned to store.
Medical	2/14/16	6200 block of Magnolia Lane – report of person having breathing problems; officers assisted in getting person in ambulance to go to hospital.
Medical	2/14/16	10000 block of Ives Way – report of unconscious person; on arrival person breathing but still unconscious. Found they were diabetic and given medication by paramedics. Officers were then cleared from the scene.
House Fire	2/16/16	10000 block of 99 <sup>th</sup> Place – report of active house fire; on arrival officers made sure everyone was out of the residence. Primed hydrants for fire department. Officers stood by for traffic control until cleared by fire department.
Medical	2/16/16	17000 block of 72 <sup>nd</sup> Avenue – report of person with knee; on arrival officers assisted in getting person in ambulance for transport.

Theft	2/16/16	13000 block of Grove Drive – report of several juveniles stealing merchandise and exiting business without paying; officers located suspects who were arrested for theft.
Theft From Auto	2/16/16	6200 block of Hemlock Lane – report of driver’s window being smashed and items stolen out of parked vehicle; no suspects at this time.
Medical	2/17/16	16000 block of Lake Ridge Drive – report of person having chest pain; on arrival officers assisted in getting person into ambulance for transport.
Medical	2/17/16	7600 block of Wedgewood Court – report of person feeling ill; officers assisted in getting person loaded for transport to hospital.
Electrical Fire	2/18/16	8000 block of Wedgewood Lane North – report of the smell of burning electrical/plastic coming from ceiling light; light was shut off. Fire department arrived and cleared officers.
Medical	2/18/16	12900 block of Weaver Lake Road – report of a possible broken ankle; on arrival officers cleared by paramedics who transported person to hospital.
