TYPE OF INCIDENT	DATE	DESCRIPTION
Medical	1/8/16	8200 block of Main Street – report of person who fell. North ambulance transported person to hospital.
Suspicious Activity	1/8/16	8600 block of Annapolis Lane – report of person being followed all around town by neighbor; officers made contact with person and advised to stay away.
Dumpster Fire	1/9/16	9600 block of 63 rd Avenue – report of fire in dumpster behind business; on arrival fully engulfed. Officer used two squad extinguishers to knock down flames and fire department arrived and put out fire. No damage to building or business.
Seizure	1/9/16	Elm Creek Boulevard & Weaver Lake Road – report of person having seizure while driving and putting vehicle into snowbank; on arrival person recovering from seizure, was not injured and car not damaged.
