

MAPLE GROVE POLICE NEWS

Following is a synopsis of some of the incidents that occurred in the City during the week of October 9th, 2015 through October 15th, 2015. Please refer to City Web-Site Crime Mapping Section for additional details for the crimes of Burglary, Robbery, Arson, Theft and Vehicle Theft.

TYPE OF INCIDENT	DATE	DESCRIPTION
Vehicle Theft	10/9/15	8500 block of Forestview Lane – report of contract worker had vehicle stolen from side of road with keys in ignition; no suspects at this time.
Medical	10/9/15	9500 block of Upland Lane – report of person getting ill and dizzy after giving blood; officers monitored on arrival and person transported to hospital by ambulance.
Suspicious Activity	10/9/15	10700 block of Boundary Creek Terrace – several complaints of solicitor in area who was given verbal warnings about no permit; on arrival person arrested for soliciting without a permit for another complaint.
Loud Party	10/9/15	6400 block of Monticello Lane – report of loud party at residence; on arrival multiple persons were cited for underage drinking and officers had parents come to pick up any juveniles.
Medical	10/10/15	9800 block of Hospital Drive – report of person at hospital that had been shot in the leg; on arrival several people interviewed with information that shooting took place in Minneapolis. An arrest was eventually made.
Medical	10/10/15	10500 block of 104 th Avenue – report of person falling for the second time today and could not get up; on arrival officers assisted her in getting up who was then transported to hospital.
Medical	10/10/15	104 th Place & Zachary – report of person very ill leaning on his vehicle; on arrival person monitored until paramedics transported to hospital. CSO's brought his vehicle to his residence for him.
Vehicle Theft	10/11/15	7000 block of Magda Drive – report of locked vehicle stolen from parking lot; no suspects at this time and vehicle still not located.
Theft From Auto	10/12/15	10700 block of 93 rd Avenue – report of catalytic converters taken off two vehicles parked in parking lot; no suspects at this time.

Theft From Auto	10/12/15	8200 block of Main Street – numerous vehicles broken into in the underground parking; suspect seen on video and crime lab responded for photos and prints. Case being investigated.
Broken Bone	10/12/15	18000 block of 77 th Place – report of person falling down stairs with possible broken ankle; on arrival assisted paramedics with transport to hospital.
Medical	10/12/15	10500 block of 104 th Avenue – report of person in seizure; on arrival person still in seizure and transported to hospital.
Juvenile Problem	10/13/15	88 th Avenue & Forestview Lane – report of juveniles lighting leaves on fire in area; on arrival officers found juvenile who admitted to doing so and were asked to leave.
Theft from Auto	10/13/15	14000 block of Weaver Lake Road – report of window smashed on car and items taken from inside while parked at business; no suspects at this time.
Medical	10/13/15	7900 block of Wedgewood Lane – report of possible heart attack; on arrival person laying on floor, conscious and breathing. Administered oxygen by mask until paramedics arrived for transport.
Suspicious Activity	10/14/15	Elm Creek Blvd & Hemlock Lane – person reported vehicle all over the road and was following; on arrival officer's located vehicle in a parking lot driving over curbs. Person arrested for DWI.
Allergic Reaction	10/15/15	13000 block of 74 th Avenue – report of person having allergic reaction and tongue was swelling; on arrival officers administered oxygen by mask and rode in ambulance to assist with airway.

During this time period there were 38 property damage traffic accidents and three property damage injury traffic accidents.
