

MAPLE GROVE POLICE NEWS

Following is a synopsis of some of the incidents that occurred in the City during the week of January 29th, 2016 through February 4th, 2016. Please refer to City Web-Site Crime Mapping Section for additional details for the crimes of Burglary, Robbery, Arson, Theft and Vehicle Theft.

TYPE OF INCIDENT	DATE	DESCRIPTION
Medical	1/29/16	7900 block of Wedgewood Lane – report of person having seizure. Officers determined the individual was diabetic and once out of seizure was given juice and food. Monitored and refused ambulance.
Vehicle Fire	1/29/16	101 st Avenue and Maple Grove Parkway – report vehicle on fire in area; on arrival vehicle burned to destruction and no one around. Officers learned vehicle was stolen out of Minneapolis. Grove. Case currently being investigated.
Medical	1/30/16	6900 block of Xene Lane – report of person falling; on arrival person conscious. Officers assisted paramedics for transport to hospital.
Medical	1/30/16	Weaver Lake Boat Launch – report of an unconscious person inside a vehicle; on arrival person conscious and waiting for friends who were ice fishing on lake. The driver was arrested for DWI.
Welfare Check	1/30/16	13800 Grove Drive – report of two adults sleeping inside a vehicle at a business; on arrival officers made contact and found they were tired and had fallen asleep.
Accident Report	1/30/16	County Road 30 and Forestview Lane – officer was flagged down by person on side of road and said that a vehicle had crashed and gone down embankment into retaining pond; officers made contact with driver who was not injured. Officers arrested driver for DWI.
Garage Fire	1/31/16	6200 block of Eagle Lake Drive – report of unattached garage on fire; on arrival garage fully engulfed. Fire department arrived and put out fire.
Damage to Property	1/31/16	9300 block of Garland Lane – report of someone damaging window, tires and decal of vehicle in underground garage; officers investigating.

Noise Disturbance	1/31/16	6500 block of Eagle Lake Drive – report of a diesel truck idling for two days at construction site; on arrival officers found truck running and contacted owner of vehicle. Officers were allowed to turn off running truck and advised owner of ordinance.
No Pay	2/1/16	6200 block of Meadowlark Lane – report of person taking taxi and not paying the fare; officers could not located parties on arrival.
Suspicious Activity	2/2/16	16000 block of County Road 30 – report of a suspicious vehicle parked in lot of a closed bank; on arrival officers made contact with person who was using the Wi-Fi. No crime occurred.
Medical	2/2/16	63 rd Avenue and Balsam Lane – report of person who had fallen, possible broken wrist; on arrival officer made contact. Transported to hospital by ambulance.
Burglary	2/2/16	14000 block of 75 th Avenue – report of suspects breaking into occupied residence; officers located suspects and arrested them for burglary.
Lift Assist	2/2/16	8600 block of Comstock Lane – report of person falling outside; on arrival officers, along with the fire department, assisted in getting person into residence. No injuries.
Open Door	2/3/16	9900 block of 105 th Place – report of neighbors garage door open all day; on arrival no fresh tracks in snow and door to residence locked. Officers closed door and secured.
Theft	2/4/16	9400 block of Dunkirk Lane – report of person taking items from store without paying; on arrival officers located suspect, who was arrested for theft.
Medical	2/4/16	10700 block of 101 st Place – report of person possibly having a heart attack; on arrival with the ambulance officers assisted paramedics and were cleared.
Welfare Check	2/4/16	8400 block of Dunkirk Lane – report of pickup truck pulling a sled with people on it; on arrival officers made contact with parties. Advised they could not be doing that and they left the area.

During this time period there were 44 property damage traffic accidents and nine property damage injury traffic accidents.
