

## MAPLE GROVE POLICE NEWS

Following is a synopsis of some of the incidents that occurred in the City during the week of February 5<sup>th</sup>, 2016 through February 11<sup>th</sup>, 2016. TYPE OF INCIDENT	DATE	DESCRIPTION
Medical	2/5/16	9100 block of Larkspur Glade North – report of person having chest pains; on arrival officers provided oxygen until transported to hospital by ambulance.
Suspicious Activity	2/5/16	17000 block of 80 <sup>th</sup> Place – report of someone pulling over in front of a house, person got out of vehicle and dropped a bag in the snow; on arrival officers were given bag that contained marijuana. No suspects at this time.
Medical	2/6/16	10000 block of 99 <sup>th</sup> Place North – report of person falling; officers arrived and were cleared by paramedics.
Damage To Property	2/6/16	13300 block of Bass Lake Road – report of person driving away from gas pump; on arrival officers noticed nozzle separated from pump. No suspect at this time.
Medical	2/6/16	9400 block of Union Terrace Lane – report of person having difficulty breathing; on arrival officers provided oxygen, paramedics transported person to hospital.

Suspicious Vehicle	2/7/16	I-94 at Weaver Lake Road – report of abandoned vehicle in median on freeway; on arrival vehicle unoccupied. Officers learned that the vehicle was stolen out of Minneapolis. No suspects at this time.

Lift Assist	2/8/16	12000 block of 71 <sup>st</sup> Place – report of person falling; on arrival officers found person at the top the stairs, assisted them back up and in their wheelchair. No injuries.
Theft	2/10/16	16500 block of County Road 30 – report of theft at a business; wallet taken from employee break room, credit cards used in other cities; on arrival officers viewed video but could not determine suspect identity.
Suspicious Activity	2/10/16	13000 block of 74 <sup>th</sup> Place – report of occupied vehicle; officers made contact with person selling home, when showing home, sellers sit in vehicle until they are gone.
Theft of Mail	2/10/16	12000 block of 85 <sup>th</sup> Place North – report of mail stolen from mailbox; officers aware of numerous thefts of mail in area. No suspects at this time.
Suspicious Person	2/10/16	12000 block of 92 <sup>nd</sup> Place – report of male at front door who said he was cold and asking for something to keep warm and was also seen looking through window; on arrival officers could not locate person.
Medical	2/11/16	8200 block of Main Street – report of possible heart attack; officers arrived, monitored and provided oxygen until paramedics arrived for transport.
Fall	2/11/16	9000 block of Zanzibar Lane – report of person falling; transported to hospital by ambulance.
Slumper	2/11/16	County Road 81 and Fernbrook Lane – report of person slumped over the steering wheel; on arrival located driver. Driver later arrested for DWI.
