TYPE OF INCIDENT	DATE	DESCRIPTION
Medical	4/24/16	7000 block of Pineview Lane – report of person having chest pains and difficulty breathing; on arrival administered oxygen until paramedics arrived for transport to hospital.
Traffic Complaint	4/24/16	Boone Avenue & I-694 – traffic complaint of vehicle traveling over the speed limit; officer stopped vehicle and arrested driver for driving under the influence.
Suspicious Activity	4/26/16	12000 block of 86 th Avenue – report of vehicle alarm going off while parked in driveway; on arrival officers met with owner. Nothing suspicious and no damage.
Medical	4/26/16	9000 block of Comstock Lane – report of person's with rapid heartbeat; on arrival assisted paramedics for transport to hospital.
Medical	4/26/16	16000 block of 86 th Avenue – report of person who cut themselves while trying to open a box; on arrival bleeding was under control and then paramedics transported person to hospital.

Vehicle Theft	4/30/16	12000 block of Arbor Lakes Parkway – report of vehicle being stolen; officers learned vehicle had been repossessed.
