RESOLUTION ACCEPTING, AND AWARDING QUOTES FOR  
THE GLEASON FIELDS ATHLETIC COMPLEX AND SITE IMPROVEMENTS PROJECT

WHEREAS, the City Council for the City of Maple Grove (“City”), authorized advertisement for bids for the Gleason Fields Athletic Complex and Site Improvements Project (“Project”) and the advertisement for bids was made as directed and authorized the City of Maple Grove Parks and Recreation Board (“Maple Grove Parks and Recreation Board” or “Board”) to manage the Project. RJM Construction, LLC (“RJM”) entered into a contract with the Board to act as the construction manager for the Project (“RJM Contract”). Pursuant to the RJM Contract any awarded contracts for the Project are to be assigned to RJM (“Assignment of Contract”) and RJM and the Board entering into guaranteed maximum price amendment (“GMP Amendment”); and

WHEREAS, bids received are listed by bid category, bidder, and bid amount on attached Exhibit A; and

WHEREAS, the Board obtained quotes for specific Project categories, each estimated less than the minimum monetary threshold requiring public bidding, which received quotes are listed by category, quoter, and quote amount on attached Exhibit A; and

NOW, THEREFORE, it is hereby resolved by the Maple Grove Parks and Recreation Board as follows:

1. The quotes listed on attached Exhibit A are accepted and the contract is awarded thereto contingent upon RJM executing the Assignment of the Contract and the GMP Amendment.
