

ASSIGNMENT OF CONTRACT

MAPLE GROVE ICE ARENA PAINTING PROJECT

THIS AGREEMENT is made as of the _____ day of April, 2022 by City of Maple Grove, a Minnesota municipal corporation (“City”), and RJM Construction, a Minnesota corporation (“Contractor”).

RECITALS

WHEREAS, City, by and through the City of Maple Grove Parks and Recreation Board, and Contractor have entered into that certain Standard Form of Agreement between Owner and Construction Manager dated April 21, 2022 (“Construction Management Document”), whereby Contractor undertakes the construction management of the project known as Ice Arena Painting Project (“Project”); and

WHEREAS, the Construction Management Document requires that the City assign to Contractor all of City’s rights in and to contracts for the construction of the Work (as defined in the Construction Management Document) which have been competitively bid or quoted as required by Minn. Stat. §471.345 and awarded by the City.

NOW, THEREFORE, in consideration of the mutual promise and agreements made in this Agreement, the Construction Management Document and other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged:

1. City hereby grants, transfers, and assigns to Contractor all of its right, title and interest in and to the contracts identified on Exhibit A and as included in the Bid Documents, subject to the Construction Management Document and the conditions herein.
2. The Contractor hereby consents to and accepts this Assignment and agrees to perform all of its obligations under the Construction Management Document for the benefit of the City. The undersigned Contractor will enter into the contracts attached as Exhibit A and in the same form included in the Bid Documents with the contractors awarded the bids and quotes by the City.
3. This Assignment shall be binding upon and inure to the benefit of the City and Contractor and their respective heirs, successors, and assigns, as the case may be.
4. This Assignment may be signed in more than one counterpart, together which shall constitute an original document.

IN WITNESS WHEREOF, City and Contractor have executed this Agreement as of the above date.
