RESOLUTION NO. 22-078

RESOLUTION ACCEPTING BID FOR EVANSWOOD PROJECT NO. 21-10 AND APPROVING DEVELOPER'S AGREEMENT FOR EVANSWOOD, SUBJECT TO FINAL REVIEW BY THE CITY ATTORNEY AND DIRECTOR OF PUBLIC WORKS

WHEREAS, pursuant to an advertisement for bids for the improvement of Evanswood Project No. 21-10, bids were received, opened and tabulated according to law, and the following bids were received complying with the advertisement:

Park Construction Company	\$15,143,554.94
S.R. Weidema, Incorporated	\$15,151,450.12
Geislinger & Sons, Inc.	\$15,601,888.38

WHEREAS, Park Construction Company of Spring Lake Park, Minnesota is the lowest responsible bidder; and

WHEREAS, a Developer's Agreement has been prepared for Evanswood; and

WHEREAS, MN LANDCO/AREP 3 EVANSWOOD, LP is required to submit a surety to the city in the amount of \$4,630,000.00 to guarantee payment of costs associated with the petition items as set forth in the developer's agreement; and

WHEREAS, MN LANDCO/AREP 3 EVANSWOOD, LP is required to submit a surety to the city in the amount of \$171,000.00 to guarantee payment of costs associated with the escrow items as set forth in Exhibit 2 in the developer's agreement.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Maple Grove, Minnesota:

1. The Mayor and Clerk are hereby authorized and directed to enter into a contract with Park Construction Company of Spring Lake Park, Minnesota in the name of the City of Maple Grove for the improvement of Evanswood Project No. 21-10 according to the plans and specifications therefore approved by the City Council and on file in the office of the City Clerk.
2. The City Clerk is hereby authorized and directed to return forthwith to all bidders the deposits made with their bids, except that the deposits of the successful bidder and the next lowest bidder shall be retained until a contract has been signed.
3. The Developer's Agreement for Evanswood is hereby approved subject to final review by the City Attorney and Director of Public Works.
