RESOLUTION NO. 23-027

RESOLUTION ESTABLISHING BUENA VISTA TERRACE & EAGLE LAKE TRAILS AREA STREET RECONSTRUCTION PROJECT NO. 23-01, ORDERING FEASIBILITY REPORT, RECEIVING FEASIBILITY REPORT, ESTABLISHING HEARING, DECLARING COSTS TO BE ASSESSED, ORDERING PREPARATION OF ASSESSMENT ROLL AND ORDERING SPECIAL ASSESSMENT HEARING.

WHEREAS, the City Council desires to proceed with the preparation of a feasibility report for the reconstruction of streets within the Buena Vista Terrace & Eagle Lake Trails Area Street Reconstruction Project No. 23-01.

WHEREAS, a report has been prepared by the Maple Grove Engineering Department with reference to Buena Vista Terrace & Eagle Lake Trails Area Street Reconstruction Project No. 23-01, and this report was received by the Council on February 6, 2023; and

WHEREAS, costs have been determined for the improvement of said Buena Vista Terrace & Eagle Lake Trails Area Street Reconstruction Project No. 23-01; and

WHEREAS, the City Council deems it advisable at this time to have the City Engineer make a determination of the city's costs with respect to Buena Vista Terrace & Eagle Lake Trails Area Street Reconstruction Project No. 23-01, and thence to prepare an assessment roll for said project and to assess the costs to the benefitting properties; and

WHEREAS, the City Council deems it advisable to set an assessment hearing for said projects.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Maple Grove, Minnesota:

1. The project shall be known as Buena Vista Terrace & Eagle Lake Trails Area Street Reconstruction Project No. 23-01.
2. The Maple Grove Engineering Department is instructed to report to the council with all convenient speed advising the council in a preliminary way as to whether the proposed improvement is feasible and as to whether it should best be made as proposed or in connection with some other improvement, and the estimated cost of the improvement as recommended.
3. A public hearing shall be held on such proposed improvement on the 6th day of March, 2023, in the Council Chambers of the Maple Grove Government Center at 7:30 p.m. and the clerk shall give mailed and published notice of such hearing and improvement as required by law.
4. The cost to be assessed against the benefitting properties is declared to be \$1,000,100.

5. The City Clerk, with the assistance of the City Engineer, is hereby instructed to prepare a determination of the city's costs and expenses with reference to Buena Vista Terrace & Eagle Lake Trails Area Street Reconstruction Project No. 23-01, and thence to prepare an assessment roll assessing project costs to the benefitted properties.
6. An assessment hearing shall be held in the Maple Grove City Council Chambers, 12800 Arbor Lakes Parkway, Maple Grove, Minnesota at 7:30 p.m. on March 6, 2023, and the clerk shall give mailed and published notice of such hearing and improvements as required by law.
