RESOLUTION NO. 23-053

A RESOLUTION ADOPTING THE 2023 UPDATE OF THE MAPLE GROVE GRAVEL MINING AREA ALTERNATIVE URBAN AREAWIDE REVIEW AS THE REVISED ENVIRONMENTAL ANALYSIS DOCUMENT AND PLAN FOR MITIGATION FOR THE GRAVEL MINING AREA

WHEREAS, the City Council of the City of Maple Grove deemed it prudent and appropriate to conduct an Alternative Urban Areawide Review (“**AUAR**”) for the area designated as the Gravel Mining Area (“**GMA**”) and ordered same on January 16, 1996; and

WHEREAS, on October 7, 1996 the City Council adopted Resolution No. 96-216 designating the Gravel Mining Area Final AUAR as the revised Environmental Analysis and Plan for Mitigation for the GMA; and

WHEREAS, on June 6, 2005 the City Council adopted Resolution No. 05-096 designating the Update of the Maple Grove Gravel Mining Area Alternative Urban Area Wide review and Mitigation Plan as the revised Environmental Analysis and Plan for Mitigation for the GMA; and

WHEREAS, on December 6, 2010 the City Council adopted Resolution No. 10-141 designating the Update of the Maple Grove Gravel Mining Area Alternative Urban Area Wide review and Mitigation Plan as the revised Environmental Analysis and Plan for Mitigation for the GMA; and

WHEREAS, on January 16, 2018 the City Council adopted Resolution No. 18-001 adopting the final AUAR as the revised Environmental Analysis Document and Plan for Mitigation for the GMA (“**2017 AUAR Update**”); and

WHEREAS, in accordance with Minnesota Environmental Quality Board Rules the *2023 Update of the Maple Grove Gravel Mining Area Alternative Urban Areawide Review (AUAR)* dated March 13, 2023 (“**2023 AUAR Update**”) was prepared and distributed in accordance with Minnesota Environmental Quality Board (“**EQB**”) Environmental Review Program Rules and for the purpose of updating the analysis and the plans for mitigation in the GMA AUAR and to maintain the validity of the 2017 AUAR Update; and

WHEREAS, the review and comment phase of the 2023 AUAR Update was completed on March 7, 2023; and

WHEREAS, comments were addressed and included as an appendix to the 2023 AUAR Update.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Maple Grove that the City Council designates the 2023 AUAR Update dated March 13, 2023 as the revised Environmental Analysis and Plan for Mitigation and adopts same in accordance with Minnesota EQB Environmental Review Program Rule 4410.3610, Subd. 5E.
