RESOLUTION NO. 23-151

RESOLUTION APPROVING THE SENIOR CITIZEN/PERMANENTLY DISABLED PERSONS ASSESSMENT DEFERRAL APPLICATIONS ON CERTAIN PID NUMBERS FOR 2022 TAX YEAR.

WHEREAS, On September 4, 1990, the Maple Grove City Council adopted Resolution No. 90-199 which provided standards and guidelines for deferral of special assessments on homestead property owned by a person 65 years of age or older, or retired by virtue of permanent and total disability for whom it would be a hardship to make special assessment payments; and

WHEREAS, the City Special Assessment Department has received applications requesting deferral of special assessments from the following listed owners of PID Nos.; and

WHEREAS, it has been determined that said applications meet the eligibility requirements for deferral of special assessments pursuant to City Resolution No. 90-199.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Maple Grove, Minnesota:

3. All such interest and principal shall be collected when the deferred assessment is payable under the provisions set forth in paragraph No. 6 of City of Maple Grove Resolution No. 90-199.
4. A copy of this Resolution shall be filed with the Hennepin County Auditor.
5. The Hennepin County Auditor shall, pursuant of M.S.A. 435.194, file a copy of this Resolution with the Hennepin County Recorder.
